Privacy Policy

This chapter informs you of our policies regarding the collection, use, and disclosure of Personal Information we receive from users of Website regarding the data protection.

We use your Personal Information only for purposes described below. By using the Website, you agree to the collection and use of information in agreement with this policy.

We do not sell, trade, or otherwise transfer to outside parties your personally identifiable information except for the purposes of Website Services providing (Disclaimer: this does not include the tools or any other third party service that may be used to make sure that we provide you the best experience regarding Website, including Website interface and analytics (for example Google Fonts, Google analytics, Meta Pixel, LinkedIn Insight Tag etc.), sending you information about existing, new or upcoming features, updates to Website for improving your experience and the tools that allow us to conduct our operations smoothly. Nevertheless, we will always strive to keep your data safe and secure.)

The purpose of data collection is:

- to create user profile on the Website for project evaluation and assessment, execution of Project Assignment ;
- to connect with users of the Website with respect to project created (including services details, price and schedule of work, project management and course of work)
- for marketing purpose (to send you information about products and services of ours that we think you might like, as well as those of our partner companies) to promote products and services on Website;
- to help develop and improve our Services and proprietary technologies

- for optimization of the product, tracking, monitoring the consumer behaviour and providing the user with helpful services as well as for evaluation of products and services we provide, commercial activities.

You are required to provide data which is necessary to create a personal account and use the Website. The data and information that identify you as an individual will be kept on our servers as long as they are needed. Upon request, by sending an email to support@devotedfusion.com from the exact email address that the account is registered on, all your information and personal data will be deleted.

1. How we collect information and how we use it

While using the Website, we may ask you to provide us with certain personal information that can be used to contact or identify you. Personal information may include but is not limited to your name, email address, birthday, telephone.

We may use your personal information for us to:

- Operate Website and provide you the best services described on Website, like to verify your identity when you sign in, autocomplete the templates with the information that you provided.
- Customize our services, like advertising that may appear on the Website, to provide a more personalised experience.
- Categorise your Portfolio and associated materials uploaded to the Website (either manually or with help of AI image recognition models).
- Update you with operational news and information about the Website, e.g., to notify you about changes, upgrades or security updates.
- Provide you with information that you request from us or, and with marketing information about products and services which we feel may interest you.
- Send you relevant and informational content that might interest or inspire you in order to help you at all the stages of your career.
- Carry out technical analysis to determine how to improve the services we provide.
- Monitor activity on Website, like to identify potentially fraudulent activity and to ensure compliance with the user terms that apply to Website.
- Manage our relationship with you, like by responding to your comments or queries submitted to us on Website or asking for your feedback or whether you want to participate in a survey.
- Manage our legal and operational affairs.
- Provide general administrative and perform functions and activities.

2. Data collected

What data and how do we collect:

We collect your personal identification information: first and last name, email address, ID data, country (state), your company or professional profile link. Also we store commercial information and on rates, payments made/due/received and applicable billing reports and your materials and deliverables you have uploaded on the Website. You directly provide us with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our services
- Voluntarily complete Project Assignment or project assignment.
- Use or view our website via your browser's cookies.

Like many web/app/software applications operators, we collect information that your browser sends whenever you visit the Website („Log Data“). This Log Data may include information such as your computer's Internet Protocol („IP“) address, your location(city, country), browser type, browser version, browser language and the pages of Website that you visit, the time and date of your visit, the time spent on those pages.

3. Cookies

Like many websites, we use „cookies” to collect information. If you do not accept cookies, you may not be able to use Website.

Within the Website, cookies are used to facilitate features and functions which improve your browsing experience. They are also used to measure the performance of the website and how visitors navigate their way around. We use them to save your log-in information so that it will make your access to the website faster and easier.

Cookies are text files containing small amounts of information which are downloaded to your device when you visit a website. Cookies are then sent back to the originating website on each subsequent visit, or to another website that recognizes that cookie. Cookies are useful because they allow a website to recognize a user's device. Cookies do lots of different jobs, like letting you navigate between pages efficiently, remembering your preferences and improving the user experience. They can also help to ensure that adverts you see online are more relevant to you and your interests. Most recent web browsers allow control over the cookies saved through the browser setting.

4. Security and data storage

Website shall manage safely and only for specified purposes, the personal data you provide about yourself.

As per this Privacy Policy, as mentioned beforehand, Website does not share, trade, or sell any of your private information and will always strive to protect it, but if you choose the option of sharing your data stored on our website (this includes for example sharing the link to your portfolio or bid or by sharing your works for receiving feedback) on 3rd party software, websites or services you do it with your consent and at your own risk acknowledging that Website cannot be held accountable for what happens with the personal information after your share it outside of Website.

By reading the „Privacy Policy” and „Terms & Conditions” you acknowledge that you are guaranteed the rights provided by law, namely the right to information, access to data, the right of intervention, right of opposition, the right not to be subjected to an individual decision, right to go to court in case of violation of these rights. You also have the right to oppose the processing of your private data and to request their total or partial deletion.

The safety and security of your information also depend on you. Where we have given you (or where you have chosen) a password or access through a unique link on your email address for access to certain parts of the Website, you are responsible for keeping the password and the content in your email inbox confidential. We ask you not to share your password, the unique information that you will receive in your email account or the login link with anyone. We urge you to be careful about giving out information in public areas of the Website like message/comment boards.

The information you choose at your own will to share publicly will be accessible by everyone who has access to that particular software, website or service, therefore, we are not able to protect it. By default, all your data is private. However, if you share your application documents on social media through or without our web application, or share your application online on a unique URL, or by email, or in public places of Website, or by third-party software, websites or services, we cannot guarantee the privacy of the data you have used in those documents and Website cannot be held liable for what happens to it after you have shared it. Therefore, we would suggest being careful where and with whom you are sharing your documents or other professional information created/shared with the Website.

We have implemented measures designed to secure your private information from accidental loss and unauthorised access, use, alteration, and disclosure. All information you provide to us is stored on our secure servers behind firewalls and in our CRM system(s). Unfortunately, the transmission of information via the internet is not 100% secure. Although we do our best to protect your private

information, we cannot guarantee the security of your private information transmitted to the Website. Any transmission of personal information is at your risk. We are not responsible for circumvention of any privacy settings or security measures contained on the Website. However, our team always strives to keep your information as secure as possible all the time.

6. Your data protection rights
